## **Holidays & Planned Absences:**

Regular fees are charged whether you attend or not. The Centre operates for a minimum of 50 weeks a year and you are charged for the bookings that you make for each child in care. If you have booked a day for your child, you will be charged for it, whether or not your child attends. Child Care Subsidy (CCS) will continue to be paid by the government providing you do not exceed the government allocated absent limit (currently 42 days per financial year).
